TERMS OF CONTRACT

Seller confirms that to the best of their knowledge, the Purchaser is receiving a healthy Kitten. Kitten will have been for a vet check prior to collection or shipping.

Kitten is sold with up to date vaccinations, worming, micro chipping and desexing. Kitten will be ready to rehome at approximately twelve weeks old.

To validate this Guarantee, the Purchaser must have his/her own veterinary examination of the Kitten within 7 business days of receiving Kitten.

If any illness is found, or purchaser changes his/her mind within this time, Purchaser must contact the seller within this 7 day period, and may at his/her option chose either, 1) return said kitten for a full refund less the deposit. 2) Return said kitten for a replacement of any colour or sex that is next available (this may mean a future litter).

Seller is never responsible for any veterinarian, medications or transport costs of said Kitten.

Transport is always at Purchaser's risk.

Since Kitten is a living creature, Seller cannot guarantee the lifetime health of this animal, nor can the Seller predict that the Kitten will not contract any illness in the future.

In the unfortunate and unlikely event that said Kitten passes prior to being received by Purchaser, the seller agrees to refund all money paid by Seller.

Any claims for medical conditions must be accompanied by a licensed veterinarian clinical notes, photos, x-rays, blood test and in case of death, an autopsy report. Eye and ear infections are not covered by Seller (See below), these are the responsibility of the Purchaser to prevent.

It is the responsibility of the Purchaser to keep Kitten up to date with all veterinary visits and vaccines. Failure to do so will be seen as neglectful and void any warranty.

If a cat sneezes once or twice a day it is not cat flu, they are just clearing mucus and dust from their nose.

Cat flu is a common name for upper respiratory tract disease. Kittens can catch Cat Flu easily by coming into contact with an infected cat, or a simple visit to a veterinary where an infected cat is present. Infected cats shed a lot of virus particles into the environment via their saliva or nasal secretions, and these may remain alive for up to a week in the environment. The symptoms for Cat Flu can lay dormant in cats for years and present itself at times of stress, like a change of environment. Cat Flu is therefore easy to contract and not covered by Seller.

Immediately after the 7 day cooling off period, Purchaser must transfer ownership of Kitten via Microchip forms provided.

A Donskoy is a very new breed. It has very few health concerns. Please shop for a veterinarian who is willing to do some research into your new family member. Please remind your veterinarian that a Donskoy is not a Sphynx! They are very different and have different needs.

Eyes: must be cleaned weekly or even daily if needed. You can use saline squirted in the eye and dry off with a soft tissue. If discharge occurs take Kitten to the veterinarian. Since a Donskoy does not have any eyelashes they get particles, like dust and carpet fibres, in their eyes. This can irritate and cause infection.

Ears: Again Kitten does not have hair in their ears to keep dirt out. Please clean weekly with ear drops, ear wipes or a soft baby Q-tip. Do it gently. Ears are not covered by Seller.

Nails: cut once a week. Make sure Kitten has many scratching posts in the house.

Bath Time: Please give Kitten a bath weekly or biweekly. Kitten may not like it, but he/she needs it. Kitten will get greasy and smelly and may leave dirty patches around the home. Use a natural baby shampoo. Not Johnsons.

DO NOT let Kitten outside. Nothing good comes from letting cats outside.

Do not use topical worming and fleeing. It can burn Kittens delicate skin. Use tablets instead.

When you get Kitten home do not change his/her food immediately. Changing cat food suddenly can cause stomach upsets and diarrhea. If you do not intend on continuing with Raw Meow as Seller does, you must mix this into the food you will use and slowly wean Kitten off it. If diarrhea occurs seek veterinary advice.

You will be given instructions on what Seller has been using on Kitten before he/she arrives.

Seller reserves the right to terminate this contract if they find, in the Sellers opinion, the purchaser to be an unfit or unsuitable cat owner. It is the Sellers prerogative to seize or have the Purchaser surrender the kitten if the Seller feels the Purchaser is unfit or mistreating the kitten or the Purchaser is not abiding to the terms of this contract. In this case the Purchaser will not be reimbursed any moneys paid to the Seller.
